Greater Meander Irrigation Scheme – Water Sales Overview (PLEASE READ THIS FIRST)

Tasmanian Irrigation Pty Ltd (TI) and the Greater Meander Irrigation Scheme (GMIS) team are pleased to advise that this irrigation project has been approved to proceed to Water Sales. Water Sales is the critical time for landholders to contractually apply for water entitlements, ensuring the project can meet a pre-determined Water Sales viability threshold and then proceed toward construction.

Any landholder interested in purchasing water is encouraged to make an offer to purchase water in the scheme, irrespective of the current pipeline alignments.

Please find enclosed Water Sales documentation for the proposed Greater Meander Irrigation Scheme. We have sent you the documents as you have either submitted an EOI for water or you have contacted Tasmanian Irrigation and requested the documents.

Water sales open on 13 May 2022 and close on Friday 24 June 2022 at 2pm. Copies of the documents are available on Tasmanian Irrigation's website at www.tasmanianirrigation.com.au/schemes/greater-meander

The sale price of water entitlements on the Greater Meander Irrigation Scheme is \$1,550 per megalitre. Landholders wishing to purchase water will be required to submit an application during the Water Sales period in conjunction with a deposit for the total amount of water being purchased.

The binding deposit of 10 per cent due upon application, with the balance of the total amount of water purchased will be due within 28 days of the commissioning (practical completion) of the scheme, or when supply is made available to irrigator.

Should irrigation water unable to be supplied to the requested location, or volume unavailable, the

deposit amount held by Tasmanian Irrigation will be refunded in full, including any interest earned on

the amount while it was held by Tasmanian Irrigation.

Tasmanian Irrigation staff will also be available at the Tasmanian Irrigation office in Deloraine, Shed 8

& 9 /155 Mole Creek Rd, Deloraine on the following days throughout the six-week sales period to assist

with contracts and answer any questions people may have in regard to the scheme and the purchase

of water:
